Christopher Désiré is also a registered tax (financial) adviser and is authorised to provide a tax (financial) service, where the advice is:

## How is your financial adviser paid?

The fees and commissions payable to Required Financial Services are explained in Part one of the FSG and also below. Consultum may retain up to 5 per cent of these fees and commissions and then pay the balance to Required Financial Services, which engages your adviser to provide financial services. Of the amount received by Required Financial Services from Consultum, your adviser is paid a salary, part of which may cover your adviser's operational expenses.

## Service and advice fees paid by you

Your initial appointment is complimentary. At this meeting, Christopher will explain how Required Financial Services operates, what you can expect and the payment options. All fees and commissions payable by you will be explained to you at the time advice is given and will also be detailed in a Statement of Advice, Record of Advice and Product Disclosure Statement(s).

You will have the ability to select your preferred payment option from the options below prior to the provision of advice. All amounts noted below are inclusive of GST:

**Statement of Advice (SoA)** – A statement of advice fee is charged to cover the cost of researching, developing, preparing and implementing your advice document. This fee ranges from \$2,200 to \$15,000 depending on complexity. Please note, our initial advice fees still apply where you decide not to implement our advice.

**Fee for service – ongoing** – Our fee for service arrangement is agreed with you at the time we prepare your SoA based on a number of factors including complexity and structure of portfolios, the ongoing need for maintenance of your portfolios and strategy, and our proposed service package offering. Our ongoing service packages commence at \$2,200 per annum or may be charged as a percentage of assets under management with an average fee of 1.1%. The services offered for these fees will be outlined in your client service package explaining both the timing of portfolio and strategic reviews along with other ancillary benefits. Fees are payable by various methods which will be discussed with you based on cost, tax effectiveness as well as your cashflow considerations.

**Commission for life risk insurance products** – An initial commission of up to 130 per cent of the first year's annual premium and then ongoing commission of up to 40 per cent of the annual premium paid.

## Other benefits

Required Financial Services has referral arrangements in place. If business is placed as a result of a referral, full details of any applicable referral fee will be provided in your individual Statement of Advice.
